### APPROVAL OF MEETING MINUTES

**A Motion** was made by Mr. Ferris and seconded by Ms. Broad to approve the Minutes of the January 15, 2025 meeting of the Board. The motion unanimously carried.

## **MANAGER'S REPORT**

**Plant Operations** - Mr. Wagner reported the facility was not in compliance with one parameter, ammonia, during the month of January, 2025, due to the extremely cold wastewater temperatures. He also reported a utility water line failed due to the extreme cold and staff installed new stainless-steel piping.

**Primary Clarifier Repair** – Mr. Wagner reported there was an emergency repair needed for the primary clarifier due to an issue with the gear box. Currently a schedule is being established for raising the gear box for inspection and/or repair.

**Sewer Main Blockage** – Mr. Bonjo reported the Authority had a blockage in a sewer main on February 17<sup>th</sup> in Conshohocken, resulting in a backup into one home on Durant Street. The line was immediately jetted, and cleared.

## **ENGINEER'S REPORT**

Mr. Mason had nothing to report at this time.

## **SOLICITOR'S REPORT**

Approve Agreement for Sewer Easement for 2110 Magnolia Lane – Mr. Glassman requested approval of an Agreement for Encroachment into an Authority Sewer Easement for 2110 Magnolia Lane, due to the extension of their existing deck. The owners of 2110 Magnolia Lane have signed the Agreement and are asking for Board approval.

**A Motion** was made by Mr. Ferris, seconded by Ms. Quirus, to approve the Agreement for Encroachment into Sewer Easement for 2110 Magnolia Lane, Lafayette Hill. The motion unanimously carried.

#### FINANCIAL REPORT

Ms. Hagey presented the financial statement for January 2025 and stated the monthly expenditures for approval tonight total \$258,753.67.
